I invite your attention to the references cited (Copies enclosed). In the reference 1<sup>st</sup> and 2<sup>nd</sup> cited, Government have sanctioned 6569 posts under RMSA Scheme to the Schools Existing in the State. Among others, 440 additional posts of School Assistants are sanctioned to the Municipal Administration Department Schools. A District-wise & School wise break up is enclosed for ready reference.

2. Therefore, I instruct you to issue instructions to your concerned Municipalities of your region to take further action on the following:-

- (i) Include these posts to cadre strength of the schools mentioning as RMSA posts on each post sanctioned
- (ii) All these posts and GO Nos should be mentioned in attendance register as well as Scale Register in all schools as RMSA post for future references.

3. Further, for filling up of the newly sanction posts, it is directed to follow the Education Service Rules & A.P. State & Subordinate Service Rules as the draft Service Rules of Municipal Teachers are pending at Government level and report compliance within (7) days.

4. This should be treated as **Most Urgent**.
